<b>Eligible Applicants</b>	<ul style="list-style-type: none"> <li>• Entry into the Promotion is open to: <ul style="list-style-type: none"> <li>○ Australian citizens and residents and international students who are living within Australia at the time of booking.</li> <li>○ individuals who hold a student visa issued by the Australian Government which is valid as at the date of entry into the Promotion, for the duration of the Promotion, and for the period during which they occupy a room and/or bed at any one of the Properties.</li> </ul> </li> <li>• Any entries by applicants under 18 years of age must be authorised by a legal guardian.</li> <li>• Applicants must also meet the following requirements in order to enter the Promotion: <ul style="list-style-type: none"> <li>○ Applicants and their referrals must have signed a residential tenancy agreement relating to Property for a minimum of 26 weeks;</li> <li>○ Applicants and their referrals must be a new resident at one of the Properties;</li> <li>○ Applicants and their referrals must have a valid and current student card with an Australian university or similar tertiary education facility. ### 1. Definition and acknowledgement

- In these Terms and Conditions, "you" refers to any person entering the Promotion.

### 2. Taxes
